2.0 HAZARDS IDENTIFICATION.

Anti-spatter, paste for welding purposes. Consists of Vegetable fat and Vaseline – (a chemically pure substance, Free of chlorine and silicone).

2.1 Classification of the substance or mixture. The product is not classified as hazardous within the meaning of Regulation (EC) No 1272/2008.

2.2 Label elements.

2.3 Other hazards. The mixture does not contain substances classified as PBT. The mixture does not contain substances classified as vPvB. 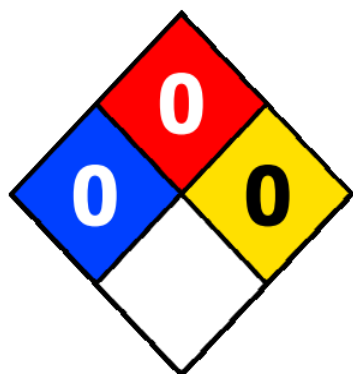
